The Planning Commission acts as an advisory body to the City Council and holds public hearings on a wide variety of development issues, including Zoning, Platting, Conditional Use Permits and Variances. In addition, the Planning Commission develops long-range plans to guide the physical development of the community through a comprehensive planning process. Term length is 3 years. Members are limited to two full consecutive terms per resolution 2005-208. Meetings are held the 2nd and 4th Wednesday of each month at 7:00 p.m. at City Hall.
