The Planning Commission is instrumental in determining both current development and future land use patterns. The Planning Commission acts as an advisory body to the City Council and holds public hearings on a wide variety of development issues, including Zoning, Platting, Conditional Use Permits and Variances. In addition, the Planning Commission develops long-range plans to guide the physical development of the community through a comprehensive planning process. The commission is comprised of nine voting members representing the city at-large. Term length is three years. Members are limited to two full consecutive terms per resolution 2008-38. Meetings are held the 2nd and 4th Wednesday of each month at 7:00 p.m. at City Hall.
